SUBJECT: 2001 Estimated Water Use Report Addendum

This addendum is to provide updated water use information for Lakeland Utilities, water use permit number 20004912.005.

Water use information for Lakeland Utilities is routinely provided in the Estimated Water Use Reports annually prepared and distributed by the District. In the course of preparing *Estimated Water Use 2001*, Lakeland Utilities provided District staff with documentation of an acceptable, previously undocumented population estimation methodology. Application of the methodology results in changes to Lakeland Utilities' estimated service area population and calculated per capita water use provided in Table A-1 of the 1998, 1999, and 2000 versions of the Estimated Water Use Report. These revised estimates also affect Table D-6 of *Estimated Water Use 2000*, which presents historical per capita water use for public supply permittees.

According to the updated population estimates, Lakeland Utilities' service area population and resultant per capita water use rate for the affected years are estimated as provided in Table 1, below.

gpcd = gallons per capita daily

On a related note, the per capita water use value for Lakeland Utilities' 2001 water use as provided in Table D-6 of Estimated Water Use 2001 should be changed to reflect the same per capita value included in Table A-1, or 152 gpcd.
