\* Aquifers are underground layers of rock and sand that hold water. In southwest Florida, more than 80 percent of the water supply comes from aquifers.

**Central** (Hillsborough, Pasco, Pinellas and Polk counties)

**South** (Charlotte, DeSoto, Hardee, Highlands, Manatee and Sarasota counties)

\*\*\* The **percentile** compares current aquifer levels to historical levels during the same time of year on a scale of 0-100. For example, the if groundwater level is at the 50<sup>th</sup> percentile, it means that half of the historical levels for this time of year were higher and half were lower than the current level.

\*\*\*\* Any level that falls between the 25<sup>th</sup> and the 75<sup>th</sup> percentile is considered **normal**. Less than the 25<sup>th</sup> would be considered below normal and above the 75<sup>th</sup> percentile is above normal.

\* **Streamflow**, also known as discharge, is the volume of water passing a location in a certain amount of time, usually measured as cubic feet per second.

\*\* The **percentile** compares current flows to historical flows during the same time of year on a scale of 0-100. For example, if the river is shown at the 50<sup>th</sup> percentile, it means that half of the historical flows for this time of year were higher and half were lower than the current flow.

\*\*\* Any flow that falls between the 25<sup>th</sup> and the 75<sup>th</sup> percentile is considered **normal**. Less than the 25<sup>th</sup> would be considered below normal and above the 75<sup>th</sup> above normal.
